The signer will furnish any accessories not furnished by the School of Music. The School of Music is under no obligation to furnish accessories. Any accessories issued with the instrument must be returned with the instrument.

Instruments are supplied to students as a convenience and not as an obligation of the University of Utah School of Music. **If instruments are not returned before or on August 1, 2021 the signer agrees to pay a fee of \$10.00 for every day the instrument is late.**
